# A kinder world – with every choice.



I write to you at a personal time of reflection. This year marks my 40th year in animal advocacy and of my service with Animals Australia.

The early years were a vibrant time of firsts. The Senate Select Committee on Animal Welfare (SSCAW), led by Democrats leader Senator Don Chipp, enabled the first public discussion of the routine but legal travesties of live export and intensive farming. The SSCAW put animal welfare on the political radar ... but sadly the courage to change the status quo and act on the SSCAW recommendations was not part of the political playbook in the 1980s.

In recent decades Animals Australia has embraced a different advocacy methodology; investigations and media exposure of animal suffering, social media and web-based digital campaigning, corporate lobbying and advertising – together enabling hundreds of thousands of caring Australians to raise their voices on behalf of animals. As a result, achievements such as the Albanese government's commitment to phase out the live sheep trade have been realised and empowered, informed consumers have reduced the numbers of hens enduring the pain and suffering of battery cages by 75% over the past 20 years.

Our ability to tell the animals' stories, to speak on their behalf, has been the key to change.

More and more people are recognising the uniqueness and sentience of animals, and that each and every choice we make hastens us towards a kinder world for them. Thank you so sincerely for travelling this long road with us – you make it possible.

# Awakening the best in us.



As you will have seen, pigs are the focus of our public campaigns this year because despite them being one of the most unique, intelligent and sensitive species who share our planet with us – they are sadly, one of the most abused.

Underpinning this is one primary factor: whenever an animal is categorised as food and destined to be slaughtered, human hearts close to them – and with that they lose access to legal protection, and the best in us – our *kindness and compassion*.

We hold such high hopes for these new campaigns because we deeply understand that humanity's treatment of farmed animals does not reflect *who we are*. Rather, it reflects *adopted*, *outdated belief systems*.

Current animal production and slaughter systems are based on thinking from another era that saw these species as 'lesser beings' – there for us to utilise, regardless of the consequences for them.

Times have changed, and we have changed.

But our hearts can't guide our choices if we *do not know* what animals are enduring ... This is why, *'You didn't know, did you?'* is such an important public campaign as it reveals the unpalatable hidden reality for mother pigs and their babies in factory farms. *'Be their Hero'* presents such a beautiful example of the power of kindness and how, if we had the opportunity to get to know these animals, our thinking and our choices would change forever.



# War and conflict zones.

#### UKRAINE

It takes enormous courage and selflessness to put animals first in times of conflict. Amidst immense suffering and widespread destruction, the brave team at Sirius Shelter in Ukraine continue to help animals during the ongoing devastation of war. Our Emergency Grants response is providing funds to assist the largest shelter in the country to give critical care to thousands of rescued animals by funding veterinary care, equipment to transport and treat animals and materials to build essential shelter until animals can be safely rehomed or reunited.

Thanks to the generous support of Animals Australia donors, Simba the lion was rescued from a life of confinement in a zoo in war-ravaged Ukraine. Although he still bears the scars of war, Simba now lives in peace at Simbonga Sanctuary in South Africa.



#### GAZA

Our grants program continues to support Gaza's only animal shelter and rescue service – Sulala Animal Rescue. Amidst countless airstrikes again this year, this team responded to endless animal emergencies and provided critical care and shelter support for the many animals who would otherwise have no one looking out for them in this region.


#### PAKISTAN AND UKRAINE FLOODS

When catastrophic floods hit Pakistan and Ukraine, Animals Australia's Emergency Grants Program was activated. Very few animal protection organisations operate in Pakistan, but as always, there were kindhearted people saving lives in the aftermath of these unprecedented floods, reinforcing our belief that compassion knows no borders. We supported the efforts of local partners Lucky Animal Protection in Pakistan, and Pegasus Shelter in Ukraine, to rescue and care for floodaffected animals, and provide a safe space and care for hundreds of animals in need.

Our Emergency Grants Program assisted the courageous and dedicated team from Pegasus Shelter to rescue and care for animals caught up in the devastating dam flooding crisis in Kherson, Ukraine.

#### SYRIA EARTHQUAKE

With many thousands of lives lost and millions displaced, the devastating impacts on animals and people from the massive earthquake in Türkiye and Syria were almost incomprehensible. Our grants program provided immediate and lifesaving support to the dedicated team at Animals Syria in the aftermath of the disaster, funding rescue efforts, urgent veterinary supplies, fuel for transportation of critical care patients, and materials to repair damage to their shelter.

# Helping native animals in need.

Again, this year, we've taken on some of the biggest issues facing native wildlife. We've kept their plight firmly on government agendas and have inspired caring people both here and around the world to help create a kinder future for them.

Like many animals we work on behalf of, Australian wildlife continue to suffer at the hands of government and industry. With their status of 'protected' stripped from them, they are routinely and legally killed across the country for recreation, profit, or convenience.

Thanks to our generous donors who are also our most powerful advocates, our work focused on protecting kangaroos, ducks, dingoes, and other native animals who are killed in staggeringly high numbers, mostly out of sight from our community who respect and admire these unique animals. We took every opportunity to provide our expertise in the form of legal representation, public campaigning, and government liaison work, giving them the strongest possible voice.

## Campaigning for kangaroos.

There is much needed hope on the horizon for kangaroos. This year we saw global corporations Nike and Puma finally announce they will stop using kangaroos to make their sports shoes, opting instead for kinder and more sustainable non-animal alternatives.

We've been proud to support many years of international campaigning by The Center for a Humane Economy and Kangaroos Alive on this issue, and is a very significant step forward that will spare thousands of kangaroos from being killed. But there is much work to be done at home to compel our decision-makers to end the biggest land-based commercial slaughter in the world – the kangaroo shooting industry.

Our campaigning this year kept the plight of kangaroos front of mind of caring Australians in the leadup to two state elections. We reminded voters in NSW and VIC of the brutal reality many kangaroos and their joeys face under the cover of darkness at the hands of the commercial shooting industry. With your support, we won't rest until the nightly cruelty of kangaroos being shot and their joeys legally bludgeoned and beheaded, ends for good.

The awful treatment of the threatened and 'protected' dingo was exposed by
our colleagues Defend the Wild and Farm Transparency Project. Thousands of our
supporters brought this to the attention of the Victorian Government, calling on them to
stop unjustly targeting and killing dingoes to appease the animal agriculture industry.

#### DID YOU KNOW?

This year, more major sporting brands announced the shift away from using kangaroo skin for soccer boots. While corporations on the other side of the world are cutting ties with the cruel commercial kangaroo industry, governments here continue to allow these iconic native animals to be shot, decapitated and bludgeoned – and so our work continues.




# A voice for Victorian waterbirds.

Despite our calls for duck shooting seasons to be cancelled due to critically low waterbird populations and cruelty concerns, state governments in Victoria, South Australia and Tasmania allowed it to continue. But not without intense scrutiny. We finally saw encouraging signs that this year's shooting season could be Victoria's last. With government reviews underway in both Victoria and South Australia, our public campaign work continued as strongly as ever.

We completed formal submissions in both states, and appeared before the Victorian Parliamentary Committee, to give detailed evidence of our many years of involvement protecting birds during the annual killing season. We applauded the Committee's recommendation of a full ban on recreational duck and quail shooting in Victoria, and we hope to see the government adopt and legislate a ban on this archaic activity, for good.

## Record-setting public inquiry.

Thanks to thousands of Animals Australia supporters and other compassionate Victorians, the number of public submissions to the state's duck shooting inquiry was the largest ever seen in the Victorian Parliament's history!

Efforts to end live sheep export.



Thanks to our donors, our live export investigations continued through the year. Evidence captured by our investigations team formed the basis of official legal complaints to the Commonwealth regulator in Australia, and supported campaigns by our international colleagues to end the global trade. The Australian Government's pledge to phase out live sheep export was a critical step in sparing Australian animals from suffering gruelling sea journeys, but our work is far from done. Thanks to your support, we've taken every opportunity; government advocacy, undercover investigations, and legal action, to ensure the end date is brought as close as possible.

# Securing the end date of live sheep export.

20 years after Animals Australia's first investigation into the cruelty of the live sheep export trade, the pathway has been cleared to bring it to an end. In 2023 an Independent Panel was formed to provide the Albanese government with recommendations on how and when the phase-out should occur.

Securing the closest possible end-date, and ensuring the phase-out is written into law, has been the highest priority. And Animals Australia supporters have embraced every opportunity to give these animals the representation they still need, and so deserve. Thousands of our supporters kept sustained pressure on Federal Labor to fast-track their policy, gave animals a voice during the public consultation on the phase-out, and bravely ensured sheep were represented at fiery live export forums. The Panel will provide its recommendations to the government by the end of September 2023.

# Our investigations uncover more cruelty.

With the live export industry rallying against the phase-out, the importance of our investigations has never been more evident. And it's your support that has ensured our investigators could be deployed at a moment's notice.

What we discovered in Oman in the weeks leading up to the 2023 Festival of Sacrifice could only be described as a total disregard for Australian live export laws, exposing thousands of sheep to terrifying slaughter. And once again, the only reason that anybody knew was because of an Animals Australia investigation.

We lodged six legal complaints with the Commonwealth regulator over a four-week period as the situation escalated, ultimately taking the fight for these animals all the way to the Federal Court.

# Alleged abuse of Australian sheep in Oman investigated

# **Representing sheep** in Federal Court.

With exporters breaking the law and sheep abandoned to cruelty, our legal team left no stone unturned. On a cold Monday night in Melbourne, we stood in front of a Federal Court Judge to request an urgent trial in a final desperate attempt to force action to help Australian sheep in Oman.

While we were granted a trial, it became clear that time had run out for these animals. A month of regulator and exporter inaction had already sealed their fate. All we could do now was get our investigators back in the field, mitigate suffering where we could, and ensure that no animal suffers in vain. The unwavering generosity of our donors enabled us to do just that.

It shouldn't be left to a charity to police wealthy export companies. And it shouldn't be up to members of the community to fund these efforts to put us in the courtroom or in the field - to be anywhere that animals need us. But without us - without you - the victims of this trade would have nobody looking out for them.

# **Brazil** court orders ban on live export.



Animals Australia's evidence of Brazilian cattle suffering in the live export trade underpinned a Federal Court ruling in Brazil calling for an end to live cattle exports from the country. While it's likely the historic ruling will be challenged, the Judge's comments - which recognised the sentience of animals - reflected an important shift in how courts view our moral responsibility to the animals subjected to this global trade.

# Campaigns for those hidden but not forgotten.

Pigs are the focus of two new powerful TV campaigns launched by Animals Australia this year. One hard-hitting and one uplifting but both with the potential to be life and choice changing for millions of people.

## You didn't know, did you?

Mothers of all species share the desire to give birth to their babies in comfort and protect and nurture them. Sadly, this opportunity is denied to mother pigs in factory farms. The sole reason such suffering continues is because consumers don't know the 'production' processes behind their pork, bacon, and ham products. In fact, the meat industry relies on people 'not knowing' – understanding that if they knew, they would make a different choice.

Our powerful new TV spot is changing that. 'You didn't know, did you?' reveals the cruel conditions endured by mother pigs and their babies in factory farms through the distress of an unsuspecting human mother. This TV campaign gives consumers back their power to make choices that align with their values, and through doing so, sends a strong message that such treatment of animals is no longer acceptable.

Millions of dollars every year are spent promoting products made from pigs in Australia and abroad – but we are determined to give these animals the voice they deserve, and the community the information they need to be empowered to make a kinder choice.





# Be their Hero.

This year Australians fell in love with a little piglet named Tottie. And it won't surprise you to know that this was our plan! A markedly different yet complementary strategy to 'You didn't know, did you?', 'Be their Hero' was created to give Australians an insight into just how extraordinary pigs are.

'Be their Hero' tells an unexpected tale of love and friendship between Tottie and her human hero Davo, demonstrating the transformative power of one moment of kindness. The series of three TV ads showcases the evolution of their unique relationship and how Tottie's presence in Davo's life influences his choices – not just for pigs, but for all animals.

Tottie's Oscar-worthy performance is impressive, but she represents every pig who is suffering right now inside factory farms and slaughterhouses. All Tottie needed was for someone to see her for who she is... curious, intelligent, sensitive and loveable.

# Pig gassing: shocking, but standard practice.

In March, animal protection organisation Farm Transparency Project released horrific slaughterhouse footage on ABC 7.30 of pigs screaming and gasping for air in a gas chamber. The reality of this legal and common method of slaughter shocked Australians. Only weeks later, the ABC revisited the story when Animals Australia's Legal Counsel Shatha Hamade highlighted that gas chamber slaughter does not meet basic slaughter standards in Australia – and in fact contravenes the industry's own Codes of Practice.

Thanks to your support, we have filed regulatory complaints with the relevant authorities and have joined calls for a national inquiry. Alongside amplifying the release of this important information and speaking out against it, we will continue to explore all avenues to end this cruel system, including possible legal action.

# Research exposes risks that factory farming poses to human health.

The suffering of animals in Australian factory farms is irrefutable. And now, thanks to a two-year investigation commissioned by Animals Australia, so too is the human health risk of keeping animals in crowded and unhygienic conditions.

The scientific research study conducted by the University of Canberra revealed the presence of multi-antibiotic-resistant bacteria in chicken and pig meat sold in four Australian supermarkets – Coles, Woolworths, IGA and Aldi. The bacteria identified included 'superbugs' which could render critical antibiotics for humans useless.

This ground-breaking study confirms that antibiotic-resistant bacteria are being produced as an inherent by-product of factory farming in Australia and are making their way – largely undetected – into the food chain. These shocking results will be utilised in our continued government and retailer liaison work, and to better inform our community of the risks of eating animals farmed in cruel and unhygienic factory farms.

# An end to cruel battery cages – soon, but not soon enough.

After years of campaigning to free hens from cruel battery cages, the news in August that a legal ban on this outdated farming system had been endorsed by Australian Agriculture Ministers was an enormous step forward.



The phase-out of battery cages is the result of eight years of consultation between government, industry, and animal protection groups. Animals Australia supporters were an integral part of the driving force for change, making up tens of thousands of the 167,000 individual submissions to government during the public consultation – the largest response to a review of animal welfare standards in Australian history.

While getting this legislation in place will be significant, it won't take effect in most states until 2036, condemning up to 55 million more hens to a miserable life in a battery cage in the meantime. State governments can choose to free hens from cages sooner and rest assured we'll be doing all we can to influence the fastest possible phase-out nationwide. Making our laws work for animals is an important part of the work we do. But the reality is, real and lasting societal change comes not through laws, but through a shift in thinking, attitudes and choices. Legislation, in the end, simply rubber stamps the paradigm shift that caring individuals like you have already forged and created. After all, you are the reason why numbers of hens confined for life to battery cages drop by 75% in the last 20 years. Your choices, example, leadership, and your heart, is what changes this world for animals.

Giving each and every hen the opportunity to experience the fullness of life remains our goal. Each hen freed, equals a human heart freed, equals another step towards a kinder, more beautiful world for us all.

Throughout the year, supporters gave animals trapped in factory farms strong representation, and ensured these sensitive, intelligent animals were not forgotten by decision-makers.

#### **BEHIND THE SCENES:**

# Giving animals a powerful voice.

Change for animals from a legislative and regulatory perspective is a very slow, but necessary process. While we all have a role to play in paving the way to a brighter future for them, it is critical that animals are given strong representation when decisions are being made by governments and animal industries. Over the past 12 months, our CEO Glenys Oogjes and fellow experts represented animals across Australia and internationally. We continued to serve on State Animal Welfare Advisory Committees (in Victoria and Tasmania) providing input into state-based animal protection laws and reviews.

Animals Australia remained a key stakeholder of the federal Live Export Animal Welfare Advisory Group, providing a critical animal protection perspective to discussions that would otherwise be dominated by a focus on economics and profits. We made a comprehensive submission and attended panel hearings during the consultation on the phase-out of live sheep export by sea and contributed to other live export reviews including the new Export Control Orders, and on the Exporter Supply Chain Assurance Scheme and the Australian Standard for the Export of Livestock.

During the recent Inquiry into recreational duck and quail shooting in Victoria, we completed a comprehensive submission and presented evidence at a hearing of the Select Committee of the Victorian Upper House. In South Australia too we completed a submission to the South Australian Select Committee on Hunting Native Birds.



Animals Australia's Glenys Oogjes and Louise Bonomi presented to the committee during the recent Inquiry into Victoria's recreational native bird hunting arrangements.

We provided input on behalf of animals into other regulatory and parliamentary reviews, including:

- Australian Standards and Guidelines for Animal Welfare we are a key stakeholder of the guideline review and update process. Current and recent reviews include the following.
- Poultry Standards review our active participation continues beyond this eight-year review, to see hens freed from battery cages well before the 2036 endorsed ban.
- National Processing Facilities (abattoir) Standards and Guidelines review – this review is still underway after a year of monthly meetings as members of the Stakeholder Advisory Group.
- Review of land transport standards for horses we participated in the review process.
- State government submissions we have represented animals during the following state-based consultations:
   NSW Game and Feral Animal Control Plan
  - The flying fox lethal crop protection permit review in Queensland
  - A proposed expansion of a feedlot in Victoria
- Local government submissions we ensured animal perspectives were not forgotten at a local level, responding to the development application by Harmony Feedlot Services P/L to expand a feedlot in Victoria by thousands of cattle.



Our long running work for flying foxes has finally seen a win for these native animals in QLD with a review resulting in a three-year phase out of lethal crop protection permits in the state. Soon these unique natives will finally be protected from shooting on farms.

## **International efforts**

We provide input to international decision-making bodies via our partner organisations – foremost among them is the World Federation for Animals (WFA) of which Animals Australia is a founding member.

WFA also now convenes the International Coalition for Animal Welfare which provides formal advice to the World Organisation for Animal Welfare (formerly the OIE). Through this body, Animals Australia contributes submissions and advice on the animal welfare code chapters that set the minimum international standards, in a bid to lift animal welfare standards across the globe.





## Global emergency grants program.


